<u>24/00348/FUL</u> Ford Hill Farm. Demolition of 5 barns and replacement with 1 barn. Deadline 13th March. Councillors attended a site meeting on February 29th.

23/00066/FUL New Barn Farm, Temple Guiting. Conversion of a traditional barn to residential use and the erection of five new-build residential dwellings, the provision of landscaping, demolition of six existing agricultural barns and associated works. Councillors attended a site meeting and a public planning committee meeting on February 29th: Extensive comments are included in the clerk's report. 24/00622/TCONR 2 Windrush Court, Ford. T1- Re-pollard weeping Willow to old points. G2- Reduce 2x Hawthorn by 2m. T3- Take out Hawthorn + stump as poor specimen. T4- Pollard Willow to 3-4ft and make safe. T5- Take down Hawthorn to hedge height. Work is required as maintenance, similar work was carried out 3-4 years ago.

24/00621/TCONR Temple Guiting Primary School. T1 - Winter Cherry, reduction of 1.5 - 2 meters, thin by 20%. T9 - Sycamore, reduce co-dominant stem with decay by approximately 3.5 meters to stabilize, and balance. T12 - Goat Willow, coppice to ground Level

b. Comments posted between meetings.

<u>24/00333/TCONR</u> Pollarding of 3 limes at 4 The Templars, Temple Guiting. The following comments were posted:

The proposed treatment of 2 of the trees, which are part of the village landscape, does not seem necessary. A similar treatment of a mature lime tree about three years ago has not resulted in pollarding as intended. Instead it has left a 12 foot dead stump and further detracted from this established feature in Temple Guiting village. CDC then responded that they agreed with the comments about the scale of the proposed works. A revised specification has been submitted reducing the tree to the same height as the 2 limes on the edge of the copse which have previously been reduced in height. TGPC agreed with the tree officer and posted 'no objection' comments.
